Thank you for taking part in "*The 2014 Wicklow Gaol 1 Night of Fright*" Halloween Charity Ghost Hunt.

As this event has been organised by Nick Thurston under the umbrella of C.A.S.P.E.R. U.K. in conjunction with Wicklow Gaol, I need you to carefully read and sign the statement below.

IMPORTANT: if anyone arrives under the influence of alcohol or drugs and/or is suspected of bringing alcohol drinks to the event, they will be not be allowed to stay for the night and will be asked to leave the premises immediately.

- 1.** Wicklow Gaol **do not** allow smoking indoors. Please also ensure that no candles or other potential fire hazards are used during your stay.
- 2.** There are no sleeping facilities at Wicklow Gaol, but a "**Safe Room**" with electricity and Toilets will be on hand.
- 3.** C.A.S.P.E.R. U.K. or Wicklow Gaol will not be liable for any loss or damage to equipment belonging to the participants, during and after the event, even if caused by poltergeist activity.
- 4.** Although we cannot foresee any problems, accidents/incidents do happen. All individuals will be covered with Third Party Public Liability Insurance, which is included in the fee. **You are staying at the location at your own risk. We accept no liability for any accident or injury to yourselves, however caused.**
- 5.** By agreeing to these terms and conditions you further indemnify the organisers/promoters from and against all legal liability in respect of any costs, claims, damages, demands, penalties, actions, proceedings, suits, losses or expenses in respect of or arising out of the injury to or the death of any person, or damage to any property arising from my participation in the activity.

6. All luggage, clothing, equipment, vehicles and effects belonging to you or your party are your own responsibility. C.A.S.P.E.R. U.K. and Wicklow Gaol are not responsible for the safe custody of attendee's property, for its loss, damage or theft.

You are responsible for making your own decisions and it is understood that when myself or a member of C.A.S.P.E.R. U.K., the Medium or a member of any of the Group in general suggest something to you, it is an opinion, and should NOT be interpreted as the only course of action.

7. As the investigation will take place in darkness all participants should bring a torch and spare batteries and are welcome to bring photographic equipment such as a digital camera or a camcorder with Night vision.

8. We suggest you either secure further accommodation for the following day/night or book transport home due to tiredness caused by the event. We do not accept any responsibility for any accidents or incidents caused after the event. Please note that tickets are available including the subsidised cost of return travel from Newry and this option is advised for safety and navigation purposes. Anyone travelling must ensure they respect the terms and conditions of the travel operator Rooney's. Tiredness kills.

9. Throughout the event, also including travel if applicable, you and your party will act in a sensible manner and will not cause disruption, harm or injury to anyone else, any animal, effect of property, etc.

10. Please note that all stories about the location are not fabricated. C.A.S.P.E.R. U.K. and Wicklow Gaol have on occasions witnessed and recorded paranormal activity in various locations. We cannot guarantee that paranormal activity will take place, but so far to date, the ghosts haven't disappointed. We accept no responsibility if you have to change clothing after a sighting or incident.

11. Please be advised that the maximum number of guests is 40 per night at Wicklow Gaol. **Participants should be aged 18 years or over, however a Disclaimer is available for minors to be signed via the Parent or Guardian.**

There will subsequently be C.A.S.P.E.R. U.K. and an Invigilator/Historian from Wicklow Gaol present on both nights (subject to change) that will accrue additional people as the hosts of the events.

CASPER UK will include at least one Spiritual Medium.
